Introduction

Childwatch International is a global network of research institutions with a strong focus on inter-disciplinary child research. The Key Institutions collaborate to strengthen child research and promote the use of researched based knowledge in development of policy and practice, for the purpose of improving children's well-being around the world.

In 2004 the network has concentrated a lot of its work on two major tasks: Preparing for and promoting the global child research conference *Childhoods 2005: Children in Emerging and Transforming Societies*. Childwatch International is co-organizing this conference with the University of Oslo, Norway. The Childwatch network contributes to this conference through its global perspective and resources. A lot of effort has been put into planning and preparing for this event by the members of the network, through study groups and other coordinating efforts.

A second major task for Childwatch International in 2004 has been to strengthen the network internally as well as strengthen its impact on the international child research agenda. This has implied efforts to improve communication within the network and to a greater extent involve the various Key Institutions in shaping the network to clarify both the aims of the network as well as the ways of reaching these goals. A process of rewriting the basic documents of the network and clarifying its governance structure has been in the focus of this task.

The network has continued its focus on the African continent. Efforts to map the status of child research in Southern Africa, through a regional research symposium, and to support the regional network in East Africa have been made.

A regional network has also been supported in Latin-America where the established group has continued its extensive collaborative work, which has resulted in a publication on children living in circumstances of poverty, marginalization and violence on the continent.

The following report gives an overview of Childwatch supported and initiated activities in 2004.

Network Activities 2004

During the year 2004 Childwatch International Research Network has organized most of its activities in study groups. Many of the former networks and partnerships developed into study groups, partly aiming at contributing and presenting their work at the conference *Childhoods 2005: Children in Emerging and Transforming Societies*. The network has in addition initiated several new study groups working towards the conference. This major international child research conference, to be held at the University of Oslo, Norway, 29 June – 3 July 2005, has been high on the agenda of the network for the last few years.

Network development has been a major challenge and an important activity for Childwatch International during 2004. Work has been done to improve communication within the network as well as to strengthen our ties and contacts with major international organizations and other relevant agencies. In addition a lot of energy has gone into reviewing and elaborating the basic documents of the network.

In the following, a short description of each of the study groups and their activities in 2004 will be presented, followed by a description of other network activities. The Key Institutions are mentioned not by name but by country. A list of Key Institutions can be found at the end of the report.

Study groups

The study groups are organized around a research theme. A main aim for all the study groups is publishing and/or development of tools for improved child research and practise. The study groups have a large variety of working methods, ranging from planning sessions at the conference through communicating by e-mail and telephone, to meeting and sharing research and experiences, to organizing large international comparative research projects. Most of the study groups will continue their collaborative work after the 2005 conference.

The conference proved a good opportunity for Childwatch International to initiate and support study groups that deal with important issues on the international child research agenda. The study groups consist of members from Childwatch Key Institutions. Some of the groups also have members from outside of the network. The groups may be organized within a geographical region or globally.

Established Childwatch study groups

Children and Media (The influence of information and communication audio-visual technologies (ICATs) on children's and adolescents' life and cultures - and on the relationship between adults and young people)

This project aims at a broader understanding of the positive and negative effects of the media on children's learning processes, socialization, rights and well-being. The group consists of members of Key Institutions in Brazil, India, South Africa, Spain and Norway. The members have gathered comparable data in their

respective countries which the group has compiled and elaborated into comparative results.

In 2004 the members have finalized their national reports which are to be compiled and published in 2005. Ferran Casas of Spain and Irene Rizzini of Brazil represented the group at The 4th World Summit on Media for Children and Adolescents in Rio de Janeiro in April. No group meetings have been held in 2004. A grant was given to the group to develop an application to apply for funding to further develop the project. The results of this process are not yet clear. The first stage of the project will end with the launch of its final publication at the Childhoods 2005 conference in Oslo.

Children and the consequences of AIDS in East Africa

The study group focuses on the consequences of the hiv/aids epidemic for the children of East Africa. The study group was formed as a result of the Childwatch initiative to strengthen its efforts in the region, starting with a consultancy and a regional child research conference organized by the Childwatch Key Institution in Kenya in 2003. In 2005 the group elaborated a number of funding applications for research projects aiming at one common collaborative research project on the issue of children and hiv/aids in the region. The group is organizing a regional sub-session at the Childhoods 2005 conference.

Children growing up in the context of poverty and marginalization

The study group is working to identify research on the topic of childhood in societies suffering from poverty and a high prevalence of violence in Latin-America. The group developed out of the Partnership between the Childwatch Key Institutions in Brazil, Colombia and Venezuela which had its closing meeting in 2004. The group has expanded and has members from several parts of Latin America and the Caribbean, including Chile, Costa Rica, Jamaica and Mexico.

When holding the final Latin American Partnership meeting in September in Rio de Janeiro in 2004 the group organized a major Latin American conference in collaboration with CIESPI and the Institute for Social Work at the Pontifical Catholic University of Rio de Janeiro. This gathered researchers from the whole continent.

In 2004 Childwatch International supported the publishing of a book on the situation of children living in circumstances of poverty, marginalization and violence in Latin America.

In addition to presenting its own work at the Childhoods 2005 conference, the group is planning to set up an international panel on the issue.

Children's Perspectives on Citizenship and Nation-building

The members of this study group are working on a comparative study of children's participation and citizenship. It aims at a better understanding of children's experiences of being active citizens within different cultures and societies. The group consists of members from Australia, Brazil, Czech Republic, New Zealand, Norway (NOSEB), Palestine, South Africa and the USA. The research includes doing focus group interviews with children in two

age groups and of different social economic status, as well as gathering quantitative data through questionnaires to adults. The national studies are being funded from outside of the network.

In 2004 the group members applied for funding and initiated data gathering for the national studies. One meeting was held in Rio de Janeiro in November, where the members met to discuss the process, the methodologies and the development of the project. The national data will be compiled and the group has plans to publish a book on the project. The group is planning a session at the Childhoods 2005 conference.

Identifying common challenges for child research in the Arab speaking countries

The study group is working to identify common challenges in child research in the Arab speaking countries, as well as to secure the relevance of and strengthen the capacity of child research in the region. The study group is a result of the established Partnership Program between a group of child researchers in Palestine and Norway (NOVA). It also includes participation by researchers from the Childwatch Key Institution in Jordan. The study group collaborates with several other institutions in the region, within the framework of the Arab Middle East North Africa (MENA) Network for Children under Difficult Circumstances.

The study group organized its second workshop in collaboration with the MENA network in Jordan in 2004. In addition to members of the study group, the workshop had participants from Morocco, Egypt, Lebanon and Sudan. The group is planning to do a common research project based on the two workshops. The group is organizing a session at the Childhoods 2005 conference.

Indicators on Children's Well-Being

An important task which Childwatch has supported from its beginning is the effort to develop methods of identifying the best possible indicators of children's rights and well-being in different countries and cultures. The methods and tools shall take cultural differences into consideration, and aim at saying something substantial about how children are doing and what resources exist in their everyday life, rather than more traditional methods that mostly focus on what resources they are lacking.

In 2004 the network has given some support to the coordinating group for the session on children's welfare (see Conference groups). Childwatch has in addition taken advantage of the group's expertise in the work of the regional groups.

Childwatch has two active regional study groups on the topic: One in South Africa, which aims at expanding into a southern African regional group; and one in East and Central Europe.

In connection to a major conference on indicators of child well-being, the study group in South Africa organized a technical meeting aiming at improving existing indicators, the use of these indicators and collection of data on children's well-being. Special emphasis was put on including children in research. The technical meeting was sponsored by Childwatch International, including support for the participation of two international experts on the issue.

One representative of this group will present the work at the conference in Oslo in June – July.

The study group on Indicators of Children's Well-being in East and Central-Europe aims at compiling already existing data on child well-being in the region and map the systems of gathering information on children's lives in order to map the needs of new data and methods of collecting these. The study group meetings have had participants from large parts of the region. In 2004 the group followed up the initiative from 2002 and 2003 with a smaller meeting in Prague in November 2004. The meeting had representatives from Czech Republic, Estonia, Hungary, Slovenia, as well as from USA and Norway. It has plans to expand its efforts in 2005, as well as coordinate a sub-session on the theme under the larger Measuring and Monitoring children's well-being session at the Childhoods 2005 conference.

Religion and Spirituality of Children in Emerging and Transforming Societies

This study group has divided its work into three sub-themes that will be addressed by a group of theologians and child researchers. The group aims at examining the relation between religion and spirituality and the development and well-being of children in emerging and transforming societies. The sub-themes are: The theology of childhoods, children's rights and social justice; The meaning of spiritual experiences and religious beliefs in children's lives; The development of religious identity. The group has participants from the Czech Republic, the Dominican Republic, Estonia, India, Norway, South Africa and the USA. The work will lead to a comparative research project connected to the research questions listed above.

One study group meeting was held in 2004 in the USA to prepare for the conference. In addition, a sub-group with participants from England, India and Norway, held a smaller meeting in England.

Socio-Cultural Contexts of Child Participation in the Asia Pacific Region

This is a sub-group under the theme of Children's Perspectives on Citizenship and Nation-building. The group aims at compiling existing research on children's participation in the Asia Pacific region in order to discuss different understandings of the concept of participation within different countries and cultures in the region. The group has members from Australia, China, India and Thailand. The new Key Institution in Sri Lanka and several institutions with a child research focus in India have been invited to join the project.

In 2004 the group held its second study group meeting in Mumbai. The work will be presented at the Childhoods 2005 conference.

Conference study groups

Caring for Separated Children

The study group aims at gathering existing data and experiences in order to present "best practices" within different institutionalized care arrangements for children outside the family. It is jointly organized and funded by the conference secretariat and Childwatch International. It has members from the Childwatch Key Institutions in England, Ireland and Norway (NOVA) as well as members

from Sweden and the USA. The group met twice in 2004. It is organizing a session for the Childhoods 2005 conference.

Children and Trafficking

This group works to define the concept of trafficking in a way that may guide a targeted response from the communities involved. In addition it works to elaborate strategies for research and practice based on an understanding of the nature of trafficking within different cultural and geographical contexts.

The group is led by Anne Hatløy at FAFO in Oslo, and representatives of NGOs and research institutions in Asia, Africa and Europe are involved in the group. The Childwatch Key Institution in Italy is a part of the study group. The group held one meeting sponsored by Childwatch International in 2004. A session at the Childhoods 2005 conference is being organized by the study group.

Growing up in an era of AIDS

The study group deals with issues related to growing up in an era of HIV/AIDS, focusing both on the effect of hiv/aids on society and children's lives as well as contextualizing the epidemic within ongoing social processes. The group is led by Catrine Christiansen at the Nordic Africa Institute in Sweden. Members of the group represent the International Department of Research at the Diakonhjemmet university college in Oslo, Norway, the Childwatch Key Institution in Senegal, and England. The group is organizing a session at the Childhoods 2005 conference.

Measuring and Monitoring children's well-being

The coordinating group for the session on indicators of children's well-being at the Childhoods 2005 conference is working to map and improve existing indicators on children's well-being and everyday life. The group has been granted some travel support by Childwatch International in 2004. Childwatch has used the expertise available in this group in its regional study groups.

Other

Boys in Trouble and the Trouble with Boys

This study group aims at exploring the kinds of trouble often associated with young boys and the way this trouble is handled according to discourses of trouble and conflict and discourse of masculinity and about growing up in different parts of the world. Childwatch International has supported the initiation of this group by partly funding its first meeting.

Bridging the gap between theory, policy and practice

Childwatch International is organizing a session at the Childhoods 2005 conference focusing on the relationship between child research, policy and practice.

Consumer Culture and Social Change- Identities, Practices and Consequences on Every-day-lives

The study group aims to develop a theoretical framework and a more coherent approach on which we can build a better and more comprehensive understanding of how childhood is effected by the rise of commercial culture in different countries. The study group has been given some travel support by Childwatch International in 2004.

Child labour

Childwatch has taken the initiative to set up a session on child labour, especially focusing on child labour and education. The group is organized under the conference secretariat.

Conference committee

Childwatch International is represented in the Childhoods 2005 scientific committee by Vice-President Per Egil Mjaavatn and director Jon-Kristian Johnsen.

Strengthening child research institutions and competence building

Consultancies

Consultant visits were initiated to formalize the practice of visits of members of the network to Key Institutions with the aim of sharing expertise and experiences to build child research competence strengthen weaker institutions within the network. The institutions that receive consultants have different challenges and will receive customized advice and assistance from the Childwatch appointed consultant. The practise of consultant visits has also been a tool to initiate collaborative research projects between institutions with different available resources as well as to consider possible new Key Institutions.

In 2004 one consultant visit was made, from India to Sri Lanka. The visit ended in the presentation of an application to become a part of the network by the institution in Sri Lanka. The application was approved at the 2004 Advisory Board meeting. The two institutions involved in the consultancy have initiated collaborative projects, both between the two countries involved and regionally.

New initiatives in 2004

Child research in Southern Africa

Childwatch International organized a regional child research symposium in Lusaka, Zambia in October 2004, in conjunction with the annual Advisory Board meeting of the network. The symposium gathered 26 researchers and practitioners from Zambia, Zimbabwe, Malawi and South African in addition to the members of the Childwatch International Advisory Board.

The symposium gave an opportunity to researchers in the region to share experience and knowledge on research and research related activities within the theme Children and Youth living in circumstances of Poverty and Marginalization. It opened for discussions on challenges related to development of research capacity in the region and established contact between Childwatch International and child researchers in Southern Africa. The event also renewed and nurtured contact with our network partners in Africa.

Contact persons were appointed for each of the countries present. Childwatch International will follow up the initiative by including the group in upcoming networks events. Participants were urged to submit abstracts to the Childhoods 2005, and several members of the group will be present at the conference in June – July 2005.

Organizational Development

The former Childwatch International project “The task force on international organizations” aimed at mapping the kinds of research and knowledge used by the International Organizations (IGOs), and clarifying how this knowledge is being used in the development of guidelines and activities of the organizations. The project was initialized in 2000 as an international group of researchers collected data through a series of interviews with representatives of UNICEF, the Inter-American Development Bank and the World Bank. In 2003, the aims of the project were expanded to include using the knowledge from this project in development of the Childwatch network, its working methods and efforts to increase the use of systematic child research of a high quality as a basis for policy development. The main aim of the project is to strengthen the position and use of child research in setting the international child policy agenda. A number of activities have been carried out within this project in 2004.

A workshop was organized by the Key Institutions CIESPI of Brazil and the TATA Institute of Social Sciences in India on the theme “Growing up Disadvantaged: Comparative Perspectives on Childhood in India and Brazil” at the World Social Forum in Mumbai in January 2004.

The established contact with the mentioned IGOs was followed up by visits by Irene Rizzini to the same organizations in June 2004.

Irene Rizzini was invited to participate in the Nineteenth Pan American Child Congress, held in Mexico City in Mexico in October 2004.

Plans for closer collaboration between the Childwatch International Research Network and relevant IGOs are being discussed. As a part of this initiative, Childwatch International director Jon-Kristian Johnsen participated in the Global Partners Forum on Orphans and Vulnerable Children organized by UNICEF and the World Bank.

The Network secretariat has in 2004 on a regular basis participated in relevant meetings and seminars both in Norway and internationally.

Several IGO representatives have been invited and included into the program of the Childhoods 2005 conference, which will be an arena to further explore possible future collaboration.

Organizational Matters

Development of basic documents

In order to better fulfill the conditions of the funding organizations of Childwatch and to use resources available to its fullest potential, the Childwatch International board agreed the network was in need of a revision of its basic documents. A committee was appointed by the board at the Advisory Board meeting in Budapest in 2003 and given the task of reviewing the Terms of Reference of the Network and elaborating a work plan for the coming years.

The group prepared a reviewed Terms of Reference which was presented at the Advisory Board meeting in Lusaka, Zambia in October 2004. The new revised documents, with changes and adjustments, will be presented for approval at the Key Institutions meeting in June 2005.

Board meetings and activities

Advisory Board

The annual Childwatch International Advisory Board meeting was held in Lusaka, Zambia 5 – 6 October 2004. The board members participated actively in the conjoining regional child research symposium on Children living in Circumstances of Poverty and Marginalization.

Executive Committee

The executive committee met in Oslo in September 2004 to prepare for the Lusaka board meeting and to contribute to the planning of the Childhoods 2005 conference. Throughout 2004 the secretariat has collaborated closely with the Executive Committee in decision making and planning documents and activities of the Network.

Business Board

A business Board meeting was held in Oslo in March 2004 approving accounts and budgets of Childwatch International.

Secretariat

In 2004 the Childwatch International secretariat has undergone changes in the staffing situation. Randi Wærdahl was employed in the position as Managing Director until 1 August. Pernille Skotte was employed as project assistant until 1 August and from this date as project co-ordinator. From 1 October 2004 Jon-Kristian Johnsen entered in the position as Director of the network and head of the secretariat.

New Key Institutions

At the Advisory Board meeting in Lusaka in October 2004, four applications to become Key Institutions of the Childwatch International network were accepted. The new institutions are: Centre for Children and Young People, at Southern Cross University in Australia; The Information and Research Center (IRC) at King Hussein Foundation in Jordan; The School of Social Work and Psychosocial Sciences at the University of East Anglia, England and The

National Education Research and Evaluation Centre (NEREC) at the University of Colombo, Sri Lanka.

Economy

Funding

The Childwatch International Research Network is funded by the Norwegian Agency for Development Cooperation (Norad). The funding is administered through the Norwegian Research Council. A contract for a new three-year period was signed in 2004. This secures the network a core funding of 7,2 million Norwegian kroner (NOK) for the period 2004 – 2006.

Budget and accounts

The accounts for 2004 show a positive result at the end of the year. Due to a period of transition with understaffed secretariat, less than budgeted for was spent on the Secretariat as well as on Network development. In addition to the fact that some activities happened late 2004 and was paid for by Childwatch in 2005, the positive results mostly stems from setting aside a reserve for 2005 to cover extraordinary expenses related to the Childhoods conference.
