The recent socio-political and socio-economical transformations of “Southern societies” as well as their new cultural configurations tend to deeply modify the status of children and the roles that adults give them. They seem to have become key-agents who have to be taken into account in daily decisions, whether it is for protecting and respecting them or for considering their capacity of influence. At the same time, Medias, international organisations and NGO’s, as well as social sciences, have never been so concerned by children in these societies and all of them play a role in their increasing visibility. In 1989, the United Nations’ adoption of the “International Convention on the Rights of the Child” seems directly linked to this renewed interest in children; it has considerably contributed to make them the greatest focus of attention. Although some observers, institutions and researchers have been unconvinced by the implementation of this legislation and keep a critical look at it, it has been adopted by the majority of the countries; numerous national governments have promulgated their own laws regarding child protection; it has become one of the main frames of reference for NGO’s and international organizations linked to childhood. Thus, the legislation of children rights appears nowadays as a global moral frame which is currently shaping childhood and children in the South.

This workshop focused on Children Rights in Southern societies aims at improving our understanding on children, their rights and the effects of these rights in Southern societies. Beyond a dichotomy between local processes and global dynamics, this workshop aims at studying the way by which they influence each other by interlacing different professional point of view, experiences and observations. Far from seeing research and development field as two self-contained worlds, we perceive here dialogue between researchers and stakeholders as a tool to make better our respective approach of children in the Global South.
